## 1. Introduction

1.1 IN2MARKETS LTD (hereinafter referred to as “the Company,” “we,” “our”) is committed to protecting and respecting your privacy. This Cookies Policy (hereinafter referred to as “Policy”) explains how we collect, use, disclose, and safeguard your personal data when you interact with our Website [www.in2Markets.com](http://www.in2Markets.com) (the “Website”). We use cookies to provide you with a better, more personalized experience and improve our services. Specifically, this Policy aligns with the provisions of Article 5(3) of the ePrivacy Directive (Directive 2002/58/EC as amended by Directive 2009/136/EC) and the General Data Protection Regulation (GDPR - Regulation (EU) 2016/679) and sets forth how cookies are used to improve your experience, ensure the seamless operation of our services, and support our efforts to provide tailored solutions.

1.2 By using our Website, you consent to the use of cookies in accordance with this Policy. If you do not agree to the use of cookies, you should adjust your browser settings or refrain from using our Website.

1.3 We may update this Cookies Policy from time to time, and we will notify you of any significant changes by posting an updated version on our Website.

## 2. What Are Cookies

2.1 Cookies are small text files that are placed on your device (such as a computer, tablet, or smartphone) when you visit a Website. They help improve the Website’s functionality, remember user preferences, and gather analytical data to enhance the browsing experience.

2.2 Cookies used on our Website may include:

- First-party cookies – These are created by the Website itself and are essential for its proper functioning.
- Third-party cookies – Set by external services integrated into the Website, often used for additional features or tracking user behavior.

- Session cookies – Temporary cookies that are deleted once the browser is closed.
- Persistent cookies – Remain stored on your device for a specified period or until manually removed, allowing the Website to recognize returning users.

2.3 Most cookies do not contain personal information, but in some cases, they may be associated with data you have provided, helping us tailor your experience on the Website more effectively

## 3. Why Are Cookies Useful

3.1 Cookies play an important role in delivering a smoother and more personalized online experience by allowing websites to identify your device and recall your preferences. On our Website, we use cookies to:

- Maintain essential Website functionality and ensure seamless performance.
- Store user preferences such as selected language or regional settings.
- Monitor Website traffic and user interactions to improve functionality and content.
- Facilitate personalized advertising and assess the performance of marketing campaigns.

## 4. Types of Cookies We Use

4.1 To provide you with a smooth, secure, and customized browsing experience, our Website uses various types of cookies, each serving a specific role:

- Strictly Necessary Cookies – These are essential for the Website to function correctly. They support secure user login, platform stability, and seamless navigation. Without them, basic site operations may not be possible.
- Analytics Cookies – These cookies help us collect anonymous information about how users interact with our Website. This data allows us to monitor performance, detect issues, and

make improvements to site structure and content.

- Preference Cookies – These cookies remember your individual choices, such as language selection or saved credentials, helping us tailor the Website to your needs and make future visits more efficient.
- Marketing Cookies – These are used to track users across websites for advertising purposes. They help us serve more relevant ads and evaluate the success of our marketing campaigns. Use of these cookies is optional and subject to your consent.

4.2 Please note that if you choose to block or disable cookies, certain features of the Website may not be fully accessible or function as intended.

4.3 We would also like to clarify that:

- Our cookies do not store passwords or any sensitive personal information.
- Our cookies do not access any unrelated data from your device.
- Our cookies do not pose any threat to your device's security.

However, they do enable us to:

- Provide you with access to critical services, such as your trading account.
- Measure Website traffic and understand usage patterns.
- Identify how you found our Website (e.g., via search engines, email, referral).
- Collect technical data, such as browser type and approximate location.
- Show relevant ads to users who have previously visited our Website, without identifying them personally.
- Customize the content you see based on your interests and browsing activity.
- Store your preferred settings to simplify your interaction with the Website.

#### 4.6 Third Party Cookies
